Faculty

Chief Justice Jean Toal – South Carolina Supreme Court (retired)

Chief Justice Toal began her service as an Associate Justice on the Supreme Court on March 17, 1988, becoming the first woman to serve as a Justice in South Carolina. She was installed as Chief Justice on March 23, 2000. A native Columbian, she received her BA degree in philosophy from Agnes Scott College. Prior to her election to the South Carolina Supreme Court, Chief Justice Toal practiced law for twenty years. In addition to her service in the SC Court system, Chief Justice Toal served in the SC House of Representatives for thirteen years. Under her leadership, technology initiatives are being integrated into the eight levels of the South Carolina court system.

Jason Bobertz – SC Supreme Court

Mr. Bobertz is the Deputy Clerk of Court for the Supreme Court of South Carolina, and has been involved in assisting the Judicial Department in implementing the eFiling Pilot Program. He is a graduate of the University of Georgia and received his Juris Doctor from the University of South Carolina Law School. He has served as an adjunct professor at both the USC School of Law and Midlands Technical College.

Desa Ballard – Ballard & Watson

Ms. Ballard has been practicing law for more than thirty years. A native of Augusta, Georgia, Ms. Ballard moved to Irmo in during high school, and graduated from the University of South Carolina with a degree in journalism. She worked as a law clerk at the Supreme Court until 1987. She worked in private practice until 1997, when she opened her own law firm.
