**The signature of the Registrar of Midlands Technical College on the application form will be required to verify your academic standing.**

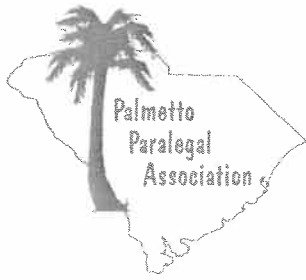
